Sealed or electronic bids must be submitted to the office *NEA Engineering Company Ltd Trade Tower*, *Thapathali*, *Kathmandu* by hand/courier or through PPMO's e-GP system <a href="www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before *12:00 Hrs*. On 7<sup>th</sup> April 2019. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of bidders or their authorized representatives who wish to attend at **NEA Engineering Company Office** On **7**<sup>th</sup> **April 2019**, **14:00 Hrs.** Absence of bidder's representatives in bid opening not obstruct the bid opening.
- 6. Bids must be valid for a period of *90 days* after bid opening and must be accompanied by a bid security or scanned copy of the bid security which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
