NEA Engineering Company Limited has allocated funds from Vidyut Utapadan Company Limited towards the cost of Construction of Prefabricated Staff Quarter and Lab building and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Prefabricated Staff Quarter and Lab building NEC/MKHEP/BD/075/76/01. Bidding is open to all eligible Nepalese Bidders.
2. NEA Engineering Company Limited invites sealed bids or electronic bids from eligible bidders for the construction of [prefabricated office and Lab building under National Competitive Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs.65,00,000.00
Minimum Work experience of similar size and nature: 2 prefab steel structures value not less than NRs 49,00,000.00 of each project.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Sealed or electronic bids must be submitted to the office NEA Engineering Company Limited Thapathali Kathmandu. By hand/courier or through PPMO website www.bolpatra.gov.np. On or before 12:00 Hrs on 30th July 2019. Bids received after this deadline will be rejected.

7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hrs on 30th July 2019 at the office of NEA Engineering Company Limited Thapathali Kathmandu.

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 1,53,500.00 which shall be valid for 30 days beyond the validity period of the bid .

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
