5. Minimum Work experience of similar size and nature: at least One project of similar nature with Contract value NRs 32,00,000.00

11. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hrs. On **(7 Falgun,2076) 19th February 2020**. at the office of NEA Engineering Company Limited, Trade Tower 2nd floor, Thapathali. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **1, 02,440.00** which shall be valid for 30 days beyond the validity period of the bid.
12. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
