Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Turnover from drilling works/ geotechnical investigation works Construction works of the best Three (3) years within the last Ten (10) years: NRs 32 Million.
- Minimum work experience of similar size and nature: Two projects completed each of value not less than NRs. 24 Million 5 Hundred Thousand only.
- Minimum work experience shall be as follows:
 - In case of single entity: 2 numbers 60m NQ drilling from river bed with at least 50m drilled in overburden, and 2 numbers of 50 m inclined drilling that has been successfully or are substantially completed and that are similar to the proposed works.
 - In case of JV: each partner shall have shall have as part of their works 1 number of 60m NQ drilling from river bed with at least 50m drilled in overburden, and 1 number of 50 m inclined drilling that has been successfully or are substantially completed and that are similar to the proposed works. Additionally, at least one partner shall have as part of their works 2 Numbers 60m NQ drilling from river bed with at least 50m drilled in overburden, and 2 numbers of 50 m inclined drilling that has been successfully or are substantially completed and that are similar to the proposed works.
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **7**th **September, 2020, 14:00 Hrs.** at the office of NEA Engineering Company Limited. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 700,000.00** which shall be valid up to 4TH January 2021.
